Mayor Henner called the meeting to order at 7:00 pm with the Pledge of Allegiance.

#### **Account #19130**

Mr. Skinner asked to have the Village of Wolcott Code Enforcement Officer, Tom Sawtelle, inspect and confirm he only has 2 units at 5940 Jefferson Street. Mr. Sawtelle confirmed the basement is only being used for storage and is not considered a "unit". Mr. Skinner has asked that the water and sewer billing at this location be changed from 3 unit billings to 2. Trustee Smith made the motion to approve the recommended change from a 3 unit water and sewer billing to a 2 unit water and sewer billing. Trustee Marshall 2<sup>nd</sup> the motion. All present voted in favor.

#### 30 day-waiver on liquor license-Wolcott Screw and Bolt, LLC

The Village Clerk received a 30-day notice of NYS Liquor License for 12014 E. Main Street and asking to waive the 30 day wait period. No inspections has been done by the Village Code Enforcement Officer as of yet. Trustee Smith made the motion to table any waiver until the Code Enforcement Officer completes the necessary inspections and approves. Trustee Lewis 2<sup>nd</sup> the motion. #### Resolution 2025-9

Whereas; Chapter § 42-15 of the Village Municipal Code in regards to Compliance orders; penalties for offenses, and

Whereas; Upon determination that a violation of the Uniform Code or this chapter exists in, on or about any building or premises, the Code Enforcement Officer shall order, in writing, the remedying of the condition. Such order shall state the specific provision of the Uniform Code which the particular condition violates and shall grant such time as may be reasonably necessary for achieving compliance before proceedings to compel compliance shall be instituted. Such order shall be served personally or by notification by registered mail, and

Whereas; In addition to those penalties prescribed by state law, any person, firm or corporation who violates any provision of the Uniform Code or any rule or regulation of this chapter, or the terms or conditions of any certificate of occupancy issued by the Code Enforcement Officer, shall be liable to a civil penalty of not more than \$200 for each day or part thereof during which such violation continues. The civil penalties provided by this subsection shall be recoverable in an action instituted in the name of the Village Board on its own initiative or at the request of the Code Enforcement Officer, and

Whereas; Alternatively or in addition to an action to recover the civil penalties provided by Subsection B, the Village Board may institute any appropriate action or proceeding to prevent, restrain, enjoin, correct or abate any violation of, or to enforce any provision of, the Uniform Code or the terms or conditions of any certificate of occupancy issued by the Code Enforcement Officer.

**Also Whereas**; in accordance with NYS Property and Maintenance Code 302-1; Exterior property and premises shall be maintained in a clean, safe and sanitary condition. The occupant shall keep that part of the exterior property that such occupant occupies or controls in a clean and sanitary condition.

**BE IT THEREFORE RESOLVED THAT** since there were several complaints regarding 6088 East port Bay Road, tax Map No 76117-13-003422 in the village of Wolcott, and violation penalties due to rubbish all over the yard and alongside the house, along with no building permit on file for said property. Also, violations penalties in the amount of \$2,600 and letters from the Village Attorney have gone unheeded, the Village of Wolcott Board of Trustees has approved the Village Attorney to proceed taking the compliance issue with said property to the Supreme Court of NYS.

A new valve was installed. Found the storm sewer was directly under the water main and had a crack. This was also replaced. Some residents may experience cloudy water while purging. 150,000 gallons was purged on March 11, 2025.
