Mayor Henner called the meeting to order at 7:00 pm with the Pledge of Allegiance.

Mayor Henner introduced Village attorney, Kevin Caraccioli. He was invited to attend the meeting as he had items to discuss with the Mayor and Trustees during executive.

#### Fire Department-Ryan Henry-

Fire Chief Henry stated that the insurance renewal has been completed. He also states that all airpacks were tested and have passed.

The ladder truck was evaluated for possible electrical issues. Issues were resolved.

Fire Chief Henry states that next month start the yearly truck inspections.

#### Police Department-OIC Brian Ritchie-

#### Sewer Department-Tommy Mettler-

# RESOLUTION

## **Establishing Procedure for the Election of Certain Officers**

## for the Wolcott Volunteer Fire Department

**WHEREAS,** the Wolcott Volunteer Fire Department (the "Fire Department") is scheduled to hold its annual election of officers on April 3, 2025; and

**WHEREAS,** the Board of Trustees for the Village of Wolcott serves as the Board of Fire Commissioners (the "Board") of the Fire Department in accordance with NYS Village Law §10-1006 (12); and

**WHEREAS,** the Board is aware that several Fire Chief positions are up for election and at least three (3) members of the Fire Department have expressed interest in serving in a Fire Chief position but live outside the territory served by the Fire Department; and

WHEREAS, the Board hereby declares that the safety of the residents and businesses within the Fire Department's territory is of upmost importance to protect and thereby necessitates that no more than one (1) Fire Chief may reside outside the territory served by the Fire Department, and that Fire Chief must meet certain thresholds to maintain their position as a Fire Chief, as more fully set forth herein;

**NOW, THEREFORE,** on a motion made by Trustee Smith and seconded by Trustee Lewis it is and shall hereby be;

**RESOLVED**, that the Board of Trustees of the Village of Wolcott serving as the Board of Fire Commissioners for the Wolcott Volunteer Fire Department hereby establish the following rules for voting for Fire Chief positions up for election on April 3, 2025:

1. No more than one (1) Fire Chief may be elected from members in good standing who reside outside the territory of the Fire Department; and

2. Any elected Fire Chief who resides outside the territory of the Fire Department shall be required to respond to no less than fifteen percent (15%) of the total number of emergency response calls received by the Fire Department. The call volume of the twelve (12) months immediately preceding the election of officers shall be utilized as the denominator when estimating the 15% call volume total; and

3. All Fire Chief Candidates who reside outside the territory of the Fire Department shall be limited to running for election as Fire Chief of District 28-5 only. The candidate who receives a majority of all votes cast by members of the Fire Department in good standing shall be declared the winner. In the event more than two (2) candidates run for election and a tie occurs amongst the candidates receiving the most votes, run-off elections will be held between the candidates who tied with the most votes until one candidate receives a majority of the votes cast.

Motion having been placed before the Board of Trustees in sufficient number constituting a quorum, this resolution is hereby adopted by the following vote:
